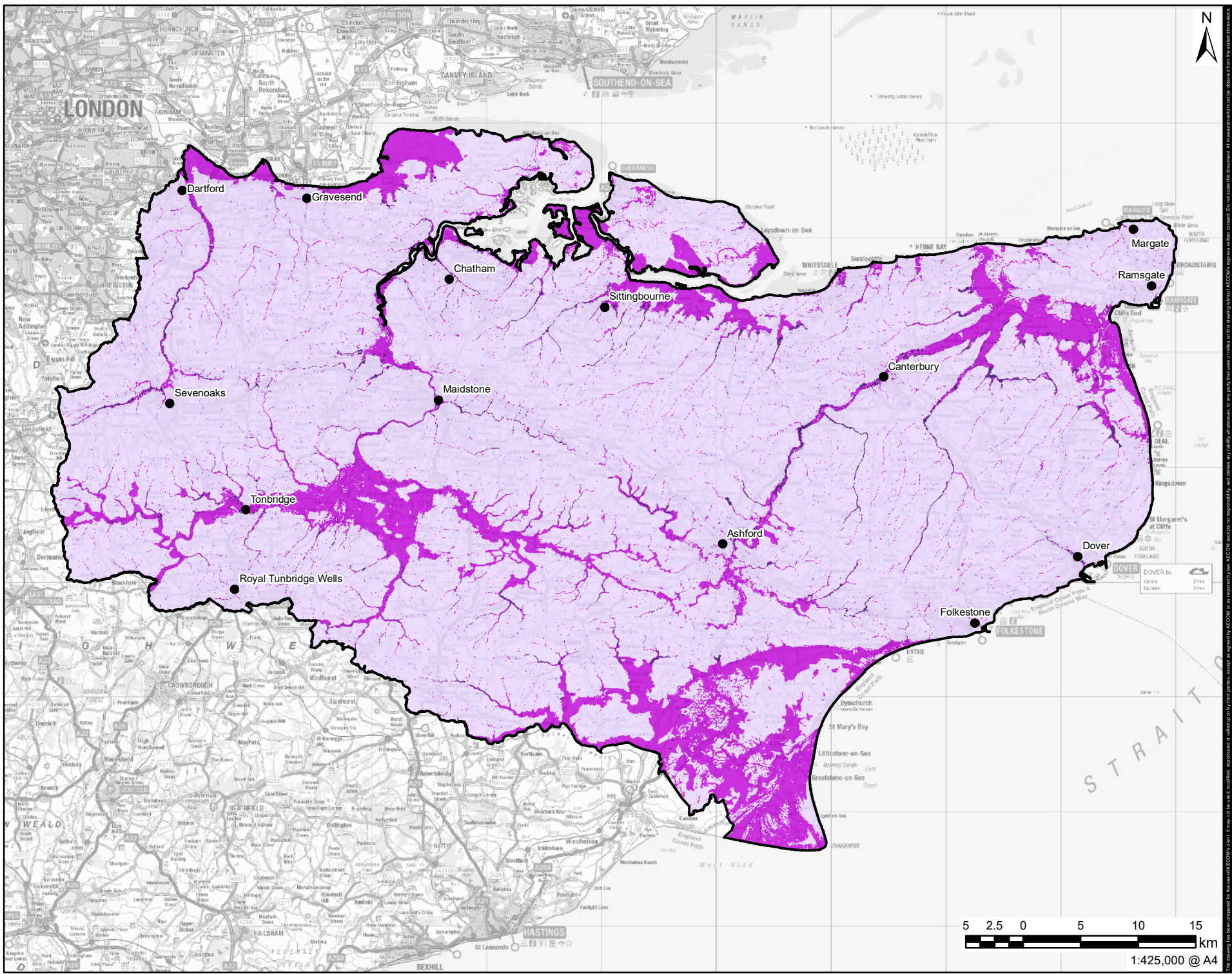


4. Water System Impact Susceptibility Maps
