

KCC Proposed Changes to Policy Text Footnotes

This document is prepared in response to the Inspector's question about whether the text of footnotes linked policies should be included in policy itself. The document sets out KCC's proposed amendments to footnotes to the policy text. It has considered where footnote content ought to go into the main body of the policy text and taken the opportunity to review the content of the footnotes more generally and propose changes where appropriate.

102	Change to "As defined in the Conservation of Habitats and Species Regulations 2017 (as amended)"
103	Delete footnote – unnecessary. Change text of main policy to reflect that AONBs are now called "National Landscapes"
104	In light of the confirmation of the date on which BNG requirements because statutory, change to "Note an application to vary a condition of a planning permission pursuant to section 73 of the Town and Country Planning Act is exempt from BNG requirements where the original permission which the section 73 application relates to was either granted before 12 February 2024 or the application for the original permission was made before 12 February 2024."
107	For information. Add the word "Currently" at the start
110	Delete footnote – unnecessary
119	For information only. Change to "Applicants should refer to Kent County Council's website for the most recent guidance on local information requirements for validation of applications."
120	Put into Policy DM17 at (18) and say "Codes of construction practice for waste developments with a capacity of over 100,000 tpa that incorporate a requirement for the majority of the construction workforce to be recruited locally. Opportunities for modern apprenticeships to be made available for a proportion of the construction workforce." FN 120 itself to be deleted.
123	Re-word for clarity: "As defined in s. 90 of the Town and Country Planning Act 1990. In relation to minerals and waste developments "ancillary development" etc."
